GPS Monitor Ordered in One Case Leads to Conviction in New Case

SPRINGFIELD, Mo. – Greene County Prosecuting Attorney Dan Patterson announces that Rebecca Ann. Marino, 34, of Springfield, MO was convicted on October 22, 2024 by a Greene County Jury of burglary in the second degree and tampering with electronic monitoring equipment.

On August 19, 2020, the owner of the Attachment & Trauma Center and left the business for the evening. Upon returning the following morning, the owner discovered that a window on the business had been shattered. It appeared that someone entered the building and stole a camera which was mounted on the sill just inside the shattered window. Additionally, a decorative pillow was stolen as well as a doll which the defendant previously gifted the business years prior when she was a client.

At the time of this offense Marino was out of jail on bond for an unrelated offense. A condition of her release required her to wear a GPS monitor. GPS data from the monitor verified that Marino was lingering in the area of Attachment & Trauma Center on the night of the burglary and at one point, the data placed her directly inside the business.

Noticing that the GPS data placed her at Kum & Go (1313 W. Battlefield Rd.) for some time during the period of time the burglary reportedly took place, video from Kum & Go was obtained by Springfield Police that showed Marino arriving at the location in her Jeep Renegade. She lingered around the business on foot then met up with an unknown male and walked in the direction of Attachment & Trauma Center. A short time later, both subjects appeared to emerge from the rear of the complex after which time Marino departed in her vehicle. She eventually returned to the area, at which time GPS data indicated she responded back to 1340 W. Battlefield Rd., placing her directly inside the business. The owner examined a still photograph captured from the Kum & Go footage and verified the female in the footage was Marino.

Soon after Marino's ankle monitor placed her at 1340 W. Battlefield Rd., she responded to the north side of Springfield and the GPS ankle monitor was deactivated.

The jury trial was presided over by The Honorable T. Myers. Judge Myers set a sentencing hearing for January 13, 2025 at 11:00 am following a sentencing assessment report by the Department of Probation and Parole.

This case is being prosecuted by Assistant Prosecuting Attorneys Ashley Twibell and Amanda Johnson. It was investigated by the Springfield Police Department and Detective Kaitlin Loney was the lead investigator assigned to the case.
