Dustin Hagerman Sentenced for 12 Felonies Following an Open Plea

SPRINGFIELD, Mo. – Greene County Prosecuting Attorney Dan Patterson announces that Dustin Cody Hagerman, 37, of Springfield, MO was sentenced 12/17/2024 for four counts of burglary in the second degree, two counts stealing of \$25,000 or more, three counts of stealing \$750 or more, tampering with a motor vehicle, stealing of a firearm, and unlawful possession of a firearm.

Hagerman entered an open plea on September 17, 2024, with sentencing set on December 17, 2024. After an hour of sentencing arguments made by the parties, The Honorable Kaiti Greenwade sentenced Hagerman to 15 years in the Missouri Department of Corrections for charges contained in the felony information.

In Count 1 charging Burglary - 2nd Degree for events that took place on or about 09/03/2021 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 2 charging Stealing - Firearm/Explosive Weapon/Ammonium Nitrate for events that took place on or about 06/02/2022 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 3 charging Unlawful Possession Of A Firearm for events that took place on or about 06/02/2022 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 4 charging Stealing - \$25,000 Or More for events that took place on or about 10/04/2022 in Springfield, Missouri, the defendant was sentenced to 15 years in the Missouri Department of Corrections.

In Count 5 charging Burglary - 2nd Degree for events that took place on or about 10/06/2022 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 6 charging Stealing - \$750 Or More for events that took place on or about 10/06/2022 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 7 charging Stealing - \$25,000 Or More for events that took place on or about 12/17/2022 in Springfield, Missouri, the defendant was sentenced to 15 years in the Missouri Department of Corrections.

In Count 8 charging Burglary - 2nd Degree for events that took place on or about 12/25/2022 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 9 charging Burglary - 2nd Degree for events that took place on or about 12/26/2022 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 10 charging Tampering With Motor Vehicle - 1st Degree for events that took place on or about 01/04/2023 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 11 charging Stealing - \$750 Or More for events that took place on or about 01/05/2023 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

In Count 12 charging Stealing - \$750 Or More for events that took place on or about 01/05/2023 in Springfield, Missouri, the defendant was sentenced to ten years in the Missouri Department of Corrections.

This case is being prosecuted by Assistant Prosecuting Attorney Ethan Auten. It was investigated by the Springfield Police Department and Detective Kolby Helms was the lead investigator assigned to the case.
